It has a broad range of material compatibility, making it an excellent choice for cleaning substrates with multiple materials of construction. *Tergo* Metal Cleaning Fluid is a non-flammable, thermally and hydrolytically stable cleaner that is a true azeotrope. Further, this fluid does not require chemical stabilizers or scavengers to prevent it from breaking down in the presence of excess water or flux activators. While *Tergo* MCF was designed for efficient use in a vapor degreaser, it is also ideally suited as a line flush fluid, or for solvent extraction applications.

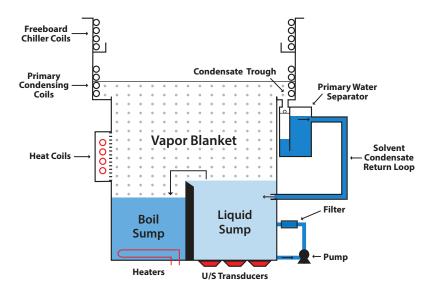

# Recovery

The azeotropic nature of this formula allows this material to be easily recoverable by simple distillation, either by utilizing the vapor degreaser itself or a still. Recovery should be closely monitored to ensure that the operating levels are maintained. Spent ingredients and still bottoms need to be disposed of according to local regulations.
